## Nominating Committee to Meet

The newly appointed Nominating Committee is scheduled to meet on Friday, February 9, 2007.

Every year each Board Trustee selects a cooperative member living in his or her district to serve on the Nominating Committee so each area is represented. The purpose of that committee is to nominate at least one person to run for Board positions that are to be elected at the Annual Meeting. Committee nominations are posted in the cooperative offices at least 20 days before the Annual Meeting.

This year, members will be elected to serve on the Board from District I, the position currently held by Robert Converse; District II, the position currently held by George Zentner, and District IV, the position currently held by Harvey Raaf.

Nominations for the positions are not limited to the ones nominated by the committee. Any 15 or more members acting together may make other nominations by petition. Nominations may also be made from the floor during the meeting. No member may nominate more than one candidate.

## Letter From The Manager

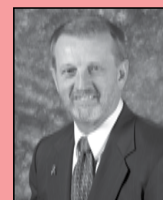
As I have mentioned before, safety is one of our main priorities here at Lyon-Coffey.

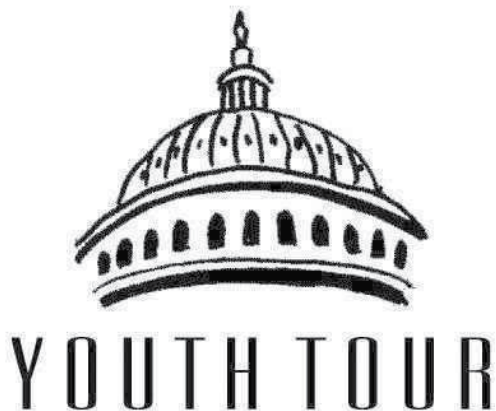
